In pursuance of Memo No. 40(Secy)-SW/O/JJA-57/17 dated 30.01.2018 and the letter from Additional Secretary to the Government of West Bengal vide memo no.6332(23)-WCD-17030/2/2024 of the Department of Women and Child Development and Social Welfare, Government of West Bengal, and as per resolution of the District Level Selection Committee, **applications** in prescribed format are invited from eligible candidates for engagement in Four different categories of posts on temporary and purely contractual basis in District Child Protection Unit, Jhargram. The contract may be renewed on yearly basis on the basis of the requirement of contractual staff for the post and upon satisfactory performance by the incumbent.

B. PROCEDURE OF APPLICATION:

- Willing candidates are required to drop hard copies of application in Prescribed formats in the drop box to be kept at DM office DCPU section (Room No-209) 2nd Floor, Office of the District Magistrate, Jhargram from 05.12.2024 to 24.12.2024 on working days from 11 am to 6 pm. Applications may be sent by registered post also. But, such applications must also be received at the District Child Protection Unit, Office of the District Magistrate, Jhargram before 6 PM of 24/12/2024.
- 2. The last date for submission of the application is 24.12.2024 till 6 p.m. Application received by hand or by registered post after the scheduled date and time will be liable to be rejected.
- 3. Online applications through a dedicated E-Mail: depujhargramrecruitment24@gmail.com address mentioned in the notification also be sent before 6 PM of 24/12/2024. Application duly signed and other supporting documents must be sent in PDF format in the said mail.

C. Mode of Selection

1. The Syllabus & distribution of marks in Written Exam, Computer Test, viva voce will be as follows:-

- 2. There will be different sets of question papers for different category of posts considering Essential Qualification for each category.
- 3. The eligibility / cut off marks for appearing in the Computer tests are 30 marks in written examination. After compilation of marks in written test and computer test top candidates in the ratio 1:5 per post will be called for Viva Voce test.
- 4. The date, time and venue of the Written Examination will be mentioned in the Admit card. Date of generation of Admit Card will be informed later in the district website.
- 5. The list of successful candidates of written examination selected for Computer test and subsequent list of successful candidates for Viva Voce will be published in District Website. No separate Admit Card or communication in any other mode shall be given to the successful candidates for Computer Test and viva voce.
- 6. Date, time and venue for Computer test and Viva Voce will be announced in the district website https://jhargram.gov.in.
- 7. The final merit list / Panel will be prepared on the basis of aggregate of marks obtained in Written Examination, Computer test and Viva Voce and will be valid for two (2) years from the date of approval of the merit list by the DLSC.
- 8. No TA/DA will be provided for appearing at the Written Examination, Computer Examination as well as Viva Voce Test.

D. General Guidelines

- 1. Along with Application the candidates are required to submit self-attested photocopy of Birth certificate/ Madhyamik admit card, Mark sheet of all Academic Qualifications, Certificate of Higher Education (if any), Computer Education and Experience, Voter card/ Aadhar Card and 2 recent colour passport size photographs (1 to be self-attested and pasted on the application form). The candidate is advised to write his/her name with father's/ guardian's name at the back of the additional photograph.
- 2. The application is to be filled up in BLOCK/CAPITAL LETTERS.
- 3. Envelope containing application should be super scribed by the name of the post applied for the top i.e. **Application for the post of**"DCPU,Jhargram ".
- 4. Defective/ incomplete applications and applications without full signature and photo will be summarily rejected.
- 5. If it is found during verification of testimonials at any stage that the candidate has acquired qualification as stated above at any date after the date of publication of this advertisement, his/her Candidate shall be summarily rejected.
- 6. Only shortlisted candidates who will be asked to appear before viva voce shall produce all relevant original certificates along with the attested photo copies for verification at the time of viva voce, failing which their candidature shall be rejected without any further communication.
