### Roles & Responsibilities

- (a) Provide regular advisory to the Chairman on improvement of efficiency of the shipyard.
- (b) Identifying & exploring new opportunities / new markets of GRSE products and help in liaisoning with customers i.e. Indian Navy establishments, Shipowners / Shipbrokers, DRDO, Industry etc. for entry into identified opportunities/ markets in a time bound manner.
- (c) Advise in preparation of company business plan for achieving the projected targets and shall help in devising business strategies to meet objectives.
- (d) Identify, evaluate & guide wrt future technologies/ opportunities in ship building and repair.
- (e) Guide in selection of technology partner and finalisation of suitable agreement meeting Customer's requirements.
- (f) Guide in setting up futuristic infrastructure with enabling technologies.
- (g) Guide in assessment and compliance with RFP/contract requirements and /or associated policy and procedure requirements.
- (h) Provide assistance to GRSE top management for apex level reviews and coordination meeting with Ministries and other Government regulatory/ policy making agencies etc.
- (i) Guide in understanding and achieving customer requirements, managing projects & programmes
- (j) Identifying the gaps in existing set-up in defence sector (including units) and provide guidance to build team and infrastructure.
- (k) Guide in planning for design and development of underwater vessels.
- (l) Guide in identifying the gaps in HR, Commercial and Finance department of GRSE and suggest suitable remedial measures.
- (m) Assist in identifying and developing suitable vendors.

### Attendance and Working Hours

However, depending upon the requirement and exigencies more than 12 days physical presence is required at workplace. Resident of Kolkata is preferred. For Non-Kolkata resident, Travel Arrangements (to & fro airfare) once in a month and Local Transport will be provided by GRSE. Normal working hours of the company will be applicable.**

### NOTES:

#### **1. EDUCATIONAL QUALIFICATION:**

- (i) For Engineering Degree (BE/B.Tech), Lateral entry to 3rd semester of 8 semester course / 2nd year of 4 years course will also be considered as equivalent qualification).
- (ii) The qualification mentioned at Graduate Level would be of full time only. No Part Time/Correspondence course will be accepted.
- (iii) **Grouping of Disciplines in Engineering Degree**
  - Mechanical – Mechanical/ Mechanical & Industrial Engg./ Mechanical & Production Engg./ Marine Engg./ Mechatronics/ Mechanical & Automation
  - Naval Architecture – Naval Architecture/ Naval Architecture & Shipbuilding/ Naval Architecture & Ocean Engg./ Naval Architecture & Marine Engg./ Ocean Engg. & Naval Architecture/ Naval Architecture & Offshore Engg.
  - Electrical – Electrical/ Electrical & Electronics/ Electrical & Instrumentation
  - Electronics – Electronics/ Electronics & Communication/ Applied Electronics & Instrumentation/ Electronics & Telecommunication/ Electronics & Instrumentation/ Instrumentation & Control
- (iv) Post graduate integrated Degree Courses will also be allowed for engineering disciplines. The integrated Professional qualification should be of 5 years duration after 10+2 qualification.

- (v) AICTE / UGC / Government of India recognized / approved Degree / PG Degree courses in concerned discipline (as referred above) awarded by University / Institution recognized by Govt. of India will only be considered
- (vi) **The date of declaration of result / issuance of mark sheet shall be deemed to be the date of acquiring the qualification and there shall be no relaxation on this account.**
- (vii) Candidates having Master degree in engineering must possess the minimum qualification prescribed against the post.

## 2. **MAXIMUM AGE LIMIT**

The maximum age limit is 65 years.

- (iii) Serving candidates of Govt. / Semi-Govt. / PSUs / Autonomous Organization to produce **No Objection Certificate (NOC)** at the time of interview.
- (iv) Please note that candidature of the candidate is liable to be cancelled if he / she submit more than one application for same post.

- (vi) **The selection for the post will be through interview.**

## 4. **APPLICATION FEES**

- (i) **Application fee is Rs. 590/- which can be remitted through online mode (Payment Gateway) by the applicants.** Applicants belonging to SC/ST/PWD are exempted from payment of Application Fee.
- (ii) The application fee is non-refundable and hence candidates are advised to ensure their eligibility for the post before applying.

- (iv) No other mode of payment will be accepted.

## 6. **GENERAL TERMS AND CONDITIONS**

- (i) The mere fact that a candidate has submitted application against the advertisement and apparently fulfilling the eligibility criteria as prescribed in the advertisement would not bestow on him/her the right to be definitely considered for selection process.
- (ii) The experience mentioned against the posts excludes any kind of traineeship including Management Trainee / Graduate Engineer Trainee etc.
- (iii) GRSE reserves the right to fill up all the posts based on suitability or increase / decrease the number of posts to be filled up or cancel any post or even cancel the whole process of engagement without assigning any reason
- (iv) Option of Hindi medium shall be given in interview.
- (v) If selected, the candidates can be posted to any Unit / Project / location of the company.
- (vi) **Final selection of candidates is subject to medical fitness by Company's Medical Officer as per Company's Rules.**

- (vii) The decision of GRSE in all matters regarding eligibility, conduct of interview and selection will be final and binding on the candidates and no correspondence will be entertained. Corrigendum if any will be issued in GRSE website only and no other communication will be made either in press or by any other mode.
- (viii) Management reserves the right to call for any additional documentary evidence in support of education, experience etc. of the applicants.
- (ix) Furnishing of false information or concealment / suppression of factual information will render the candidate unfit for employment and GRSE will not be responsible for any consequence of furnishing of such wrong / false information.
