General Instruction for State Budget & NHM M.Os:

Oualification & Other eligibility required:

A. **Educational Qualification for State Budget & NHM M.Os**: Higher Secondary examination, certified by "West Bengal Council of Higher Secondary Education" or its equivalent is the minimum education.

B. Professional Qualification for State Budget & AYUSH (NHM):

i) Professional Qualification for State Budget:

1. For Homeopathy:

A Bachelor Degree (BHMS) in Homeopathy from recognized University or Institution recognized by Central Council of Homeopathy and must be registered with State or Central Council of Homeopathy.

2. For Ayurveda:

A Bachelor Degree (BAMS) in Ayurveda from a University or its equivalent as recognized under the Indian Medicine Central Council Act, 1790. Candidate must be registered with 'Paschim Banga Ayurveda Parishad' West Bengal.

ii) Professional Qualification for AYUSH (NHM):

i) For Homeopathic:

A Post Graduate degree (MD), a Graduate (BHMS) or a Diploma (DMS/DHMS) in Homoeopathy from an Institution recognized by Central Council of Homoeopathy and must be registered with State or Central Council of Homoeopathy. (Regarding confusion about equivalency of Degree and Diploma, as per communication of Central Council of Homeopathy, vide no. 12-10/9-CCH/2296 dated 25.06.1993(copy enclosed), a candidate having less than 4 years' diploma in Homeopathy prior to enforcement of Homeopathy (Diploma course) Regulation 1983 and included in second schedule of Homeopathic Central council Act will be treated to be equivalent to degree but not for the purpose of employment).

ii) For Ayurveda:-

A degree in Ayurveda from recognized Institution established by law or Statutory Faculty/Examining Body of Indian Medicine or its equivalent as recognized under Indian Central Council Act, 1970. Candidate must be registered with Paschim Banga Ayurveda Parishad, WB.

For State Budget, at the time of Submitting application, all candidates must be registered with proper council/ Parishad and have to submit the registration Certificate, Provisional Certificate from the same authority can also be entertained but he/ she have to produce original registration Certificate within 6(six) months of his/ her selection. In anyway, late submission of Registration Certificate will not be entertained.

- C. i) Age criteria for State Budget M.O s: Entry Age of Part-time Homeopathy and Ayurvedic Medical Officer in Gram Panchayat Dispensaries shall be not more than 50 years and exit age shall be 65 years. Age should be calculated on 1st January of the Publication of recruitment notification i.e. as on 01.01.2025. Entry age limit is relaxable for 5 years for SC/ST and 3 years for OBC candidates.
 - ii) Age criteria for NHM M.O s: Not more than 50 years on the 1st January of the year of publication of notice, i.e. as on 01.01.2025 upper age limit is relaxable for 5 years for SC/ST candidates & 3 years for OBC candidates. The agreement between the doctor and the Pradhan will terminate on the date on which the doctor attains the age of 65 years.
- D. Honorarium: The present consolidated honorarium of the Medical Officers is Rs. 16000/-p.m.(Subject to fulfillment of condition).
- E. Language Known: Candidate must have knowledge in Bengali both speaking & Writing. Candidate must be a citizen of India.
